No. 32/2/98-AH.6/6188.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and all other powers enabling him in this behalf, the Governor of Punjab is pleased to make the following rules further to amend the Punjab (Non-Ministerial) Class-III Service Rules, 1992, namely :—

RULES

1. (i) These rules may be called the Punjab (Non-Ministerial) Class-III (First Amendment) Service Rules, 2003.

(ii) They shall come into force on and with effect from the date of their publication in the Official Gazette.

2. In the Punjab (Non-Ministerial) Class-III Service Rules, 1992, of Appendix 'B' under the heading captioned as "ANIMAL HEALTH AND ANIMAL PRODUCTION WING", against Serial No. 4, under Column 5, (A) for entry (i), the following shall be substituted, namely :—

(i) 10 plus 2 in second division, with Physics and Chemistry subjects from a recognized University or Institution; and

(B) in entry (ii) at the end, for the sign ' . the sign ' : ' shall be substituted; and

(C) after the entry (ii), the following proviso shall be added, namely :—
"Provided that the candidates who are already doing the prescribed Veterinary Pharmacist course after having been selected on the basis of existing qualification as per rules before the date of notification for amending the rules, shall also be eligible for appointment to the post of Veterinary Pharmacist."
